In spite of the opportunities given to the candidates to edit the application forms, match the documents and the information filled in the application form, upload the original documents etc. vide Notice dated4/3/2021 and 20/3/2021, the candidates were not proactive for verifying the details filled in and matching them with the own documents.

As a result, there were rejections at the level of Institute level round-Round III. Parents, Candidates and some Organizations urged Directorate of Higher Education and CET CELL to give more opportunity to edit the application form, last opportunity to confirm admission for Academic Year 2020-21.
