CAP Round –I: -Notice No. 1.

Reference No: Government Extraordinary Gazette No 182 14th June 2019 Page No.8. in communication with Government Extraordinary Gazette Part IV-B, 13th August 2020.

(a) If a Candidate is allotted the seat as per his/her First Preference, such allotment shall be “Auto Frozen” and the Candidate will have to accept the allotted seat. Such Candidate shall then be not eligible for participation in the subsequent CAP Round-II. Such Candidates shall then report to Allotted College for verification of documents and payment of seat acceptance fee through Candidate’s Login. Thereafter such Candidate shall report to the Allotted Institute and seek admission on the allotted seat. If such Candidate does not report to Allotted College for confirmation of seat acceptance, their claim on the allotted seat shall stand forfeited automatically and the seat shall become available for fresh allotment in Round-II. For such Candidate, the allotment so made in Round- I shall be the final allotment and they will directly go to Round-III (Institute level round) if they do not seek admission in Round-I.

(b) Candidate who have been allotted seat other than the first preference as per the preference given by the Candidate and if the Candidate is satisfied with such allotment and do not wish to participate in further CAP rounds, such Candidate can freeze the offered seat through Candidate’s Login. Once the Candidate freezes the allotted seat, such Candidate shall then report to Allotted college for verification of documents and payment of seat acceptance fee. Thereafter such Candidate shall report to the Allotted Institute and seek admission on the allotted seat. For such Candidate, the allotment so made shall be the final allotment. Such admitted candidates will not be considered for allocation in on line Round-II.

(c) If Candidate who have been allocated other than first preference and does not report to Allotted College for confirmation of seat acceptance, their claim on the allotted seat shall stand forfeited automatically and the seat shall become available for fresh allotment in round II. The Candidate who freezes the seat shall then be not eligible for participation in the subsequent CAP Round-II. If such candidates want to participate for Round-II, they will have to cancel their admission of Round-I through college log in.

(d) Candidate who have been allotted seat other than first preference and not accepted the seat by not reporting to Allotted College for confirmation of seat acceptance and not paying the seat acceptance fee through Candidate’s Login shall be eligible for participation in the subsequent Round-II.
